

**Form 56-1 One Report for Year 2025 and Financial Statements for the year ended 31 December 2025,
in QR Code format, and the Request Form for a hard copy of the documents**

The Stock Exchange of Thailand, through Thailand Securities Depository Co., Ltd. (TSD) as securities registrar, has developed a system that enables listed companies to distribute shareholder meeting materials and annual reports electronically via QR Code, providing shareholders with convenient and efficient access to this information. Shareholders may download the Form 56-1 One Report for the Year 2025 and the Financial Statements for the Year Ended 31 December 2025, by scanning the QR Code provided below and following the outlined steps:

iOS Download Instructions

1. Open the Camera application on your device.
2. Point the camera at the QR Code to scan it.
3. A notification will appear at the top of the screen. Tap the notification to access the meeting-related documents.

Note: If no notification appears, shareholders can scan the QR Code using other applications such as QR Code Reader, Facebook, or LINE.

Android Download Instructions

1. Open a QR scanning application such as QR Code Reader, Facebook, or LINE.

To scan the QR Code via LINE:

- Open the LINE application and select Add Friend.
- Select QR Code and proceed to scan the QR Code.

To scan the QR Code via Facebook:

- Open the Facebook application and tap the Search icon at the top.
- Select the QR Code icon on the right and scan the QR Code.

2. Point your device's camera at the QR Code to scan it and access the meeting-related documents.

Note: Shareholders may also scan the QR Code using other applications such as QR Code Reader, etc.
