Subject: Notification of complete correction of shareholding distribution for minor shareholders  
(Free Float)

The Stock Exchange of Thailand (“SET”)

Amarin Corporations Public Company Limited (“the Company”) would like to notify SET that the Company is able to correct the shareholding distribution of minor shareholders (Free Float) of the Company completely according to the criteria set by SET that a listed company must have no less than 150 minority shareholders, who collectively hold no less than 15% of the Company’s paid-up capital.

Siribhakditham Company Limited (the major shareholder of the Company) has disposed of its shares on two occasions, on May 19 and May 28, 2026, in order to increase the proportion of minority shareholders (Free Float), by selling 8,000,000 shares (representing 0.80% of the Company’s paid-up capital) to an individual person in Thailand and 48,000,000 shares (representing 4.81% of the Company’s paid-up capital) to Maritimus Opportunities Fund, an investment fund established in Singapore, respectively. The total number of shares disposed of across these transactions equals 56,000,000 shares, or 5.61% of the Company’s paid-up capital. In this regard, the new shareholders have not nominated any representatives to participate in the Company’s management, and are therefore classified as Non-Strategic Shareholders in accordance with the regulations prescribed by SET.

According to the information as of the closing date of the register to compile the shareholders list on 28 May 2026. The Company has minor shareholders (Non-Strategic Shareholders) totaling 1,407 persons holding a total of 149,904,355 shares, or 15.02% of the Company’s paid-up capital (excluding ordinary shareholders who hold less than one trading unit) which has already complied with the criteria set by SET. Furthermore, during the period from 28 May 2026 to 2 June 2026, there was no the Company’s share acquisition by any strategic shareholders.
