Subject Notification of the Establishment of a New Joint Venture Company

To President
The Stock Exchange of Thailand

The Board of Directors of Amarin Corporations Public Company Limited (the “Company”) at its Meeting No. 2/2026 held on 13 May 2026, and subsequently, the Executive Committee at its Meeting No. 8/2026 held on 27 August 2026, approved the terms and conditions for AME Imaginative Company Limited (“AME”), a subsidiary in which the Company holds 99.99% of the shares, which operates business in advertising, designing and producing various media, renting out advertising and public relations space, organizing exhibitions and trade fairs, as well as engaging in the entertainment business, to enter into a joint venture agreement and establish a new joint venture company together with Kruengkao Company Limited (“Kruengkao”), an expert in song, music and entertainment, with the objective of supporting the strategy of building a business ecosystem and fully expanding the entertainment business and related businesses, in order to enhance the potential, diversity and competitiveness of the Company’s group. In this regard, AME holds shares in the joint venture company in the proportion of 50% of the registered capital

The Company would like to inform you that on 8 September 2026, AME reached an agreement on the terms and conditions with the relevant counterparty, and has signed the agreement and duly established the joint venture company. The material details of the joint venture company are as follows:

Name of Joint Venture Company:	Bridge Management Company Limited (“Bridge”)
Registered and Paid-up Capital:	50,000,000 Baht, comprising 500,000 ordinary shares at 100 Baht per share, representing AME’s portion of 25,000,000 Baht
Shareholding Structure:	AME holds 250,000 shares, representing 50% of the registered capital, and Kruengkao holds 250,000 shares, representing 50% of the registered capital. The shareholders of Kruengkao are not related to the executive directors and major shareholders of the Company
